**These are the terms of our contract:**

**1. After this affiliation:**

a) Uno will insert the name and the address of your establishment in the Uno website and will assign you space to upload information about your establishment, product/services.

b) Your details will be included in the Uno website for as long as you remain an affiliate.

**2). Following your affiliation you will comply to:**

a). Recognize the Uno Cards and honor the discount agreed with must be honored all year around. Even for small amounts. There must not be a markup in your prices just for the sake of giving cardholders a discount. The discounts given must be based on the normal retail price. In this case of sales or special promotions, the Uno discount is considered void unless otherwise stated in your terms.

b). Display the Uno logo for entire duration of the agreement both inside and outside your establishment. The Uno logo signs will be supplied by us for a nominal fee.

c). Instruct your personnel on the terms of this agreement to ensure that the Uno cards are promptly recognized and accepted.

d). Check the expiry date on the Uno Card to make sure it is still valid.

e). Inform Uno about the opening of any new branches of your establishment to which this contract will be automatically extended. Furthermore, inform us with at least three months' notice if your establishment ceases to trade as the contract will then come to an end.

f). Relieve us of any liability in the case of complaints or claims by cardholders regarding any goods or services purchased from your establishment using the Uno Card.

**3. General Clauses:**

a). The present agreement is valid from the below date up until its termination by either one of the two parties by means of mutual consent. You are still required to honor the same conditions set out in this contract to Uno cardholders for 3 months from the date of termination. The Uno logo must also remain on display during this period of time. Your establishment will also be removed from future editions of our guide.

b). If your establishment is handed over to a third party you must give us immediate notice. If the name and the services provided by the new management of the establishment remain the same. It is possible for the new management to continue the contract under the same terms.

c). Uno has the rights to modify any of the present conditions and partner organizations will be informed by letter/email. If you no longer wish to comply with the new conditions. you must reply within ten days and follow instructions as explained in point 3(a).

d). Your logo and establishment description will be printed in one color.
